Madam/Sir,

This has reference to the proposal submitted by AAA College of Engineering and Technology, Sivakasi, Tamil Nadu for conferment of autonomous status.

The Commission in its meeting held on 23.12.2024 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to AAA College of Engineering and Technology, Kamarajar Educational Road, Amathur, Sivakasi, Virudhunagar District, Tamil Nadu affiliated to Anna University, Chennai, Tamil Nadu 600025 for a period of 10 years from the academic year 2025-2026 to 2034-2035 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2023.

The University is, therefore, requested to issue the necessary notification within 30 days regarding the grant of autonomous status to the College as per above mentioned UGC Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.gov.in. Non-compliance of the requirements and conditions prescribed in the said Regulations shall attract action as per Clause -13 of the UGC Regulations for Autonomous Colleges, 2023. The college shall apply to the University Grants Commission for an extension of autonomous status at least three months before the completion of the period of autonomy.

 - (ii) The College/Institute is advised to submit a report regarding Examination Cell and constitution of Statutory Bodies as required under Clauses 11 and 12 of the UGC Regulations for Autonomous College, 2023 to ensure proper management of academic, financial, and general administrative affairs. Non-compliance of the above shall attract action as per Clause -13 of the UGC Regulations – 2023.
 - (iii) The College/Institute is advised to take necessary steps for implementation of NEP 2020 and intimate the UGC.
